### ORDINANCES/RESOLUTIONS

#### **ORDINANCE 10.18:2020**

Attorney Brandon Voelker gave a second reading to Ordinance 10.18:2020 for codification of ordinances as is done annually.

**MOTION:** Luke Price made a motion to approve 2nd reading of 10.18:2020 codifying ordinances, seconded by Shannon Johnson. Motion carried 6-0-0.

### **ORDINANCE 50.01A:2020**

Attorney Brandon Voelker gave a first reading to Ordinance 50.01A:2020 for amending the FY19-20 Budget ordinance to include grant funds for CDBG, R&D Loan, and R&D Grant.

#### **ORDINANCE 55.01:2020**

Attorney Brandon Voelker gave a first reading to Ordinance 55.01:2020 authorizing the issuance of up to \$25,000,000 revenue bonds for the Texas Bluegrass Biofuels LLC Project.

**Resolution 05.05.20:1** Attorney Brandon Voelker read a resolution approving the Mayor's appointment of Shannon Clem as Police Chief of the City of Falmouth, pending approval from the Kentucky Retirement System.

• MOTION: Amy Hurst made motion to approve Resolution 05.05.2020:1 appointing Shannon Clem as Police Chief to the Falmouth Police Department pending approval from the Kentucky Retirement System; seconded by Joyce Carson. Motion carried by vote of 6-0-0.

This concluded the business for the Special meeting. Council then went into general discussion of those present by departments. No action taken.

- It was explained new water meters installed at the water plant have given more accurate readings and therefore, better numbers to report for water loss-17%.
- Debris with house on Main Street torn down still an issue.

- Discussion about the old Middle School and status of project. No one had any new information to report.
- The persons responsible for the recent vandalism had been apprehended.
- True up refund from KU would be received by July 1 in the amount of approximately \$10,000.

- Brian Thompson was present to bring Council up to speed on the CRS recertification.
   Everything had been submitted in a timely manner and he was waiting to hear back if Falmouth passed renewal.

# CITY OF FALMOUTH ORDINANCE 2020-10.18

AN ORDINANCE ENACTING AND ADOPTING SUPPLEMENT 2020 S-30 TO THE CODE OF ORDINANCES OF THE CITY OF FALMOUTH, KENTUCKY.

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2020 S-30 supplement to the Code of Ordinances of the City of Falmouth, which supplement contains all ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of this municipality; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make references to sections of the Kentucky Revised Statutes;

WHEREAS, it is the intent of Council to accept these updated sections in accordance with the changes of the law of the Commonwealth of Kentucky;

NOW, THEREFORE, BE IT ORDAINED by the City of Falmouth:

SECTION 1. That the 2020 S-30 supplement to the Code of Ordinances of the City of Falmouth, Kentucky, as submitted by American Legal Publishing Corporation of Cincinnati, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

SECTION 2. That this ordinance shall take effect and be in force from and after its date of passage, approval and publication as required by law.
