CITY OF FALMOUTH ORDINANCE 50.01A-2020

AN ORDINANCE OF THE CITY OF FALMOUTH, IN PENDLETON COUNTY, KENTUCKY, AMENDING THE ANNUAL BUDGET (ORDINANCE NO. 50.01-2019) FOR THE FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020, BY ESTIMATING REVENUES AND RESOURCES, AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FALMOUTH, PENDLETON COUNTY, KENTUCKY AS FOLLOWS:

SECTION 1: The annual budget for the fiscal year beginning July 1, 2019 and ending June 30, 2020, as set forth in Ordinance No. 50.01-2019, is amended as follows to include revenue for the following:

CDBG Grant:

\$1,000,000

RD Loan:

\$1,659,983

RD Grant:

\$553,327

That these amounts are to be included in the 2019-2020 Falmouth Budget, as if set forth in the Ordinance No. 50.01-2019, and expended for the water/sewer projects/upgrades approved by Council.

That all other budgeted items set forth in Ordinance No. 50.01-2019, shall remain in effect, until further amendment

SECTION 2:

This Ordinance shall be effective upon passage and publication.

SECTION 3:

The Invalidity of any section of this Ordinance shall not affect the

validity of any other section.

SECTION 4:

This Ordinance shall be published in Summary according to law.
