RESOLUTION 03.21.24.1 CITY OF FALMOUTH, PENDLETON COUNTY, KENTUCKY RESOLUTION OF ADOPTION OF THE NORTHERN KENTUCKY REGIONAL HAZARD MITIGATION PLAN 2024

WHEREAS, certain areas of the City of Falmouth, Kentucky are subject to periodic natural hazards, including but not limited to flooding, landslides, tornados, thunderstorms, and winter storms that have potential to cause damages to people and properties within the area; and

WHEREAS, the City of Falmouth desires to prepare and mitigate for such natural hazards; and

WHEREAS, under the Disaster Mitigation Act of 2000, the United Sates Federal Emergency Management Agency (FEMA) requires that local jurisdictions have in place a FEMA-approved Hazard Mitigation Action Plan as a condition of receipt of certain future Federal mitigation funding; and

WHEREAS, the Northern Kentucky Regional Hazard Mitigation Plan was developed in accordance with the regulations of the Disaster Mitigation Act of 2000 and the guidance provided by the Federal Emergency Management Agency; and

WHEREAS, to assist cities and counties in meeting this requirement, the Northern Kentucky Area Development District has facilitated the development of a multi-jurisdictional Hazard Mitigation Plan covering member jurisdictions of the Northern Kentucky Area Development District including the City of Falmouth, Kentucky; and

WHEREAS, the City of Falmouth, or its designated representative, has participated in the Hazard Mitigation Planning process:

NOW, therefore, be it resolved, that the City of Falmouth City Council hereby:

- 1. Adopts the Northern Kentucky Regional Hazard Mitigation Plan as the official Hazard Mitigation Plan of the City of Falmouth, Kentucky; and
- 2. Vests the Pendleton County Office of Emergency Management with the responsibility, authority, and the means to:
 - a) Inform all concerned parties of this action.
 - b) Develop an addendum to this Hazard Mitigation Plan if the jurisdiction's unique situation warrants such an addendum.
- 3. Appoints Northern Kentucky Area Development District to assure that the Hazard Mitigation Plan be reviewed according to the Plan Maintenance Procedures of the Plan and that any needed adjustment to the Plan be developed and presented to the Pendleton County Mitigation Committee and to the City of Falmouth City Council for consideration.
- 4. Agrees to consider any other official actions as may be reasonably necessary to carry out the objectives of the Northern Kentucky Regional Hazard Mitigation Action Plan for the City of Falmouth, Kentucky.

CITY OF FALMOUTH ORDINANCE 2024.3

AN ORDINANCE OF THE CITY OF FALMOUTH, IN PENDLETON COUNTY, KENTUCKY, AMENDING THE ANNUAL BUDGET (ORDINANCE NO. 2023-2) FOR THE FISCAL YEAR JULY 1, 2023 THROUGH JUNE 30, 2024, BY ESTIMATING REVENUES AND RESOURCES, AND APPROPIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FALMOUTH, PENDLETON COUNTY, KENTUCKY AS FOLLOWS:

SECTION 1: The annual budget for the fiscal year beginning July 1, 2023 and ending June 30, 2024, as set forth in Ordinance No. 2023-2, is amended as follows to include revenue for the following:

\$75,000 is taken from the Economic Development line item budgeted and a new line item City Counsel Special Counsel is created with a budgeted amount of \$30,000 (including prior budget amendment of \$20,000) and the Police Department budget is increased by \$65,000.

That these amounts are to be included in the 2023-2024 Falmouth Budget, as if set forth in the Ordinance No. 2023-2, and are expensed for the payment of Special Counsel for City Counsel and to increase the police budget for hiring of another officer for additional police coverage.

That all other budgeted items set forth in Ordinance No. 2023-2, shall remain in effect, until further amendment

SECTION 2: This Ordinance shall be effective upon passage and publication.

SECTION 3: The Invalidity of any section of this Ordinance shall not affect the validity of any other section.

SECTION 4: This Ordinance shall be published in Summary according to law.

SECTION 5: The foregoing Ordinance was read, passed, and adopted by the Council of the City of Falmouth, Kentucky, meeting in regular session on the 21st day of March 2024. Approved by the Mayor and ordered published in Summary according to law.
