Regular Council Meeting Minutes May 9, 2017

Falmouth City Council met in regular session at 7:00 pm on May 9, 2017 with Mayor Elonda L. Hinson presiding. The following Council Members were present: Amy Hurst, Ron Stinson, Alex Carson, April DeFalco, and Sebastian Ernst. Absent: Amy Hitch

With a quorum present the meeting was called to order. The meeting opened with the Pledge of Allegiance and Prayer by Council Member Amy Hurst.

Motion to approve minutes was made by Council Member Carson, with a second by Council Member Ernst. Motion passed unanimously.

Mayor introduced Brown Thornton our representative for the KYMEA group. Mr. Thornton presented council with an update on KYMEA and the renewal of the KYMEA Agreement. Mr. Thornton explained that there will be a change in rates from KU Kentucky Utilities in July 2017 and again in July 2018. All of which we will endure until the contract with KU is up in 2019. He explained to council that around the 1st of June he would have better numbers. Council will look at having a 1st reading at our Special Meeting May 18, 2017.

Fire Department

Chief David Marquardt went over monthly runs.

Water/Wastewater Department

Todd Ramsey was present and wanted to congratulate Travis Lonaker on receiving his Class III Operator License. Discussion regarding Rumpke Leachate hauling increase was discussed, council said it would be nice to see the price range showing different options of prices per 1000 gallons.

Maintenance Department

Gary Lea reported that they have been working on pot holes. Questions and issues regarding the garbage ordinance have been brought forward since the Police Department is working to enforce our current ordinances. After a lengthy discussion regarding garbage pickup council agreed that it would be best to work and revise the current ordinance to include what is needed for the safety and clearer guidelines for the workers and city residents. When working on a new ordinance the city will pay attention, to weight limits, can limits, and what items will and will not be picked up by the city.

During Mr. Lea's presentation #7 Senior Citizens Lot/County item on the agenda was brought up. County Judge David Fields previously asked the Mayor to seek approval for the city to lease or do some type of agreement to allow them to put a garage top over the location behind Ace Hardware, where they currently park the Senior Citizens transportation vans.
