## **EXECUTIVE ORDER**

March 26, 2020

## STATE OF EMEGENCY CITY OF FALMOUTH, KENTUCY

**WHEREAS**, On January 21, 2020, the United States Department of Health and Human Services Secretary Alex Azar declared a public health emergency for the novel coronavirus (COVID-19), beginning on January 27, 2020; and

WHEREAS, On March 6, 2020, Governor Andy Beshear declared a public health emergency for the Commonwealth of Kentucky for the novel coronavirus (COVID-19), and

**WHEREAS**, On March 14, 2020 Pendleton County Judge Executive David Fields declared a public health emergency for Pendleton County Kentucky for the novel coronavirus (COVID-19), and

WHEREAS, the planning and preparedness of all state and local agencies for a COVID-19 public health emergency in the Commonwealth is a concern to all Kentuckians; and

WHEREAS, the Kentucky Department of Public Health has specially trained personnel and resources to assist the sate and local authorities in protection of life, public health and safety, through coordinating a response to this emergency; and

WHEREAS, it is both appropriate and desirable to combine the resources of the Kentucky Department of Emergency Management and Kentucky Department of Public Health in joint operations with selected federal, state, and local agencies to attain the maximum effective response to the circumstances described herein;

**NOW, THEREFORE**, I, Ron Stinson, Mayor of the City of Falmouth in the state of the Commonwealth of Kentucky, by virtue of the authority vested in me by KRS 39A.100 declare that

a State of Emergency exists in Falmouth, Kentucky and do hereby order and direct the issuance of appropriate orders for the necessary officers, personnel, equipment and logistical support necessary for immediate response to the novel coronavirus (COVID-19) emergency in the City of Falmouth.
